

FUNDING SOURCES – GENERAL CREATIVE

This factsheet aims to highlight key sources of funding available to support any self-employed person or business working in the creative industries in Scotland. The funds listed include those to support professional development, business start-up, as well as activities such as skills training.

Sources of funding available to those working across the general business sector can be found within our 'Funding Sources – General Business' factsheet. Funding sources specific to your art form are listed separately; see factsheet 'Funding Sources – Literature', for example.

Public Funding

National

- **Arts & Humanities Research Council (AHRC)** – research grants and fellowships available for all post-doctoral researchers in arts and humanities disciplines but only for research that is practice-led or applied in its approach: www.ahrc.ac.uk/FundingOpportunities
- **BBC Performing Arts Fund** – helps aspiring music-makers and performers looking for a way to get ahead who for reasons of lack of existing opportunity, personal background or circumstance, would not have been able to achieve their most ambitious goals, or their talent's greatest potential without the Fund's support or intervention: www.bbc.co.uk/performingartsfund
- **National Endowment for Science, Technology and the Arts (NESTA)** – Venture and Capital funds available for innovative start-ups that match the strict arts / technology criteria: www.nesta.org.uk/investments
- **Scottish Arts Council** – the principal channel of public funding for the arts in Scotland and main source of creative professional development funding for individuals and organisations: www.scottisharts.org.uk (click 'Funding').

Regional

Grant provision differs considerably per region therefore it is essential that you check directly with your own local authority for details of actual schemes provided:

- **Aberdeenshire Arts** – 'Arts in the Community Grant Scheme' funded by Aberdeenshire Council to help groups undertake challenging new work, especially that which encourages art made by and for the local community, involving multimedia collaborations: www.aberdeenshirearts.org.uk (click 'Funding' > 'Arts in the Community')

- **Clore Duffield Foundation** – ‘Main Grants Programme’ funds for registered charities or companies limited by guarantee towards innovative projects, but also practical, straightforward proposals that will make a difference to an organisation or a particular group of people: www.cloreduffield.org.uk
- **Dewar Art Awards** – awards for exceptionally talented artists up to the age of 30 towards fulfilling their potential in any branch of the arts:

- **Esmée Fairbairn Foundation** – one of the largest independent grant-making foundations in the UK. Funds the charitable activities of organisations that have the ideas and ability to achieve change for the better. One of its primary interests is in the UK's cultural life. www.esmeefairbairn.org.uk
- **Lankelly Chase Foundation** – funds available for projects that have a recognisable charitable purpose. It encourages access to the arts especially for those in rural areas. Support for work with focus on dance, arts and special needs, transgenerational work with communities: www.lankellychase.org.uk
- **Oppenheim-John Downes Memorial Trust** – financial assistance to deserving artists of any kind, whether writers, painters, sculptors, musicians, dancers, actors, craftsmen or artists of any comparable nature or description who are unable effectively to pursue their vocation by reason of their financial difficulties. As a general guide the maximum award would be £1,000 but, in exceptional circumstances, the Trustees may consider making a larger award. Awards are made in December of each year with the closing date for applications being 15 October: www.openheimdownestrust.org
- **The Ashden Trust** – funds for community arts organisations that encourages creative projects for children, especially the very young, and for young people living in remote rural areas: www.ashdentrust.org.uk/
- **The Baring Foundation** – grants programme to strengthen the voluntary sector, the arts and international development: www.baringfoundation.org.uk (click ‘Grants Programme’)
- **The Fenton Arts Trust** – grant support to those actively contributing to the creative arts in the UK, giving scholarships and bursaries for final year or postgraduate students, grants for individuals early in their careers to support or reward work or performances, and grants for institutions or organisations which have the same aims: www.fentonartstrust.org.uk
- **The Garfield Weston Foundation** – funding to help UK registered charities set up arts, community or education projects and more: www.garfieldweston.org
- **The Paul Hamlyn Foundation** – ‘Open Grants Scheme’ for registered charities or not-for-profit organisations to support innovative ways of increasing people's enjoyment, experience and involvement in the arts. Grants are for specific activities including running costs, overheads or core costs of running your organisation: www.phf.org.uk
